On the basis of my review, except for the matters reported below in my Basis for Qualification, in my opinion no matters have come to my attention giving cause for concern that in any material respect, the information reported in this Annual Return:

- has not been prepared in accordance with proper practices;
- that relevant legislation and regulatory requirements have not been met;
- is not consistent with the Council's/Committee's governance arrangements; and
- that the Council/Committee does not have proper arrangements in place to secure economy, efficiency and effectiveness in its use of resources.

Basis for Qualification

Annual Governance Statement

In my opinion the Annual Governance Statement is not consistent with the Council's actual arrangements in the year:

• Assertion 3. S.1 of the Employment Rights Act 1996 (ERA1996), requires the Council to provide its Clerk with a written contract or a written statement of the specified terms of employment under within two months of starting employment. As part of the audit, we sought evidence that the Council had complied with section 1 of ERA 1996. We are satisfied that the Council properly appointed the Clerk and has agreed the salary. However, we established that the Clerk has not been provided with full terms of employment. In order to ensure clarity of the terms and conditions of employment we recommend that the Clerk prepare and sign a contract of employment at the earliest opportunity.
