1. Expenditure under S137 Local Government Act 1972 and S2 Local Government Act 2000

Section 137(1) of the 1972 Act permits the Council to spend on activities for which it has no other specific powers if the Council considers that the expenditure is in the interests of, and will bring direct benefit to, the area or any part of it, or all or some of its inhabitants, providing that the benefit is commensurate with the expenditure. Section 137(3) also permits the Council to incur expenditure for certain charitable and other purposes. The maximum expenditure that can be incurred under both section 137(1) and (3) for the financial year 2021-22 was £8.41 per elector.

In 2021-22, the Council made payments totalling £ 2,050.00 under section 137. These payments are included within 'Other payments' in the Accounting Statement.

I report in respect of my audit of the accounts under section 13 of the Act, whether any matters that come to my attention give cause for concern that relevant legislation and regulatory requirements have not been met. My audit has been conducted in accordance with guidance issued by the Auditor General for Wales.

Auditor General's report

Audit opinion – Qualified

On the basis of my review, except for the matters reported below in my Basis for Qualification, in my opinion no matters have come to my attention giving cause for concern that in any material respect, the information reported in this Annual Return:

- has not been prepared in accordance with proper practices;
- that relevant legislation and regulatory requirements have not been met;
- is not consistent with the Council's/Committee's governance arrangements; and
- that the Council/Committee does not have proper arrangements in place to secure economy, efficiency and effectiveness in its use of resources.

Basis for Qualification

Annual Governance Statement

In my opinion the Annual Governance Statement is not consistent with the Council's actual arrangements in the year:

- When setting its precept, the Council is required to calculate its budget requirement in accordance with the Local Government Finance Act 1992. The Act requires the Council to take into account its level of reserves when setting its budget requirement. At 31 March 2021, the Council carried forward reserves of £9,183. This equates to 115% of the precept raised during 2021-22 and 275% of its expenditure for 2021-22. In setting its precept for 2021-22, the Council disregarded the high level of reserves carried forward and therefore, in my opinion, issued an unlawful precept.
