Auditor General's report and audit opinion

I certify that I have completed the audit of the Annual Return for the year ended 31 March 2024 of **Cilymaenllwyd Community Council**. My audit has been conducted on behalf of the Auditor General for Wales and in accordance with the requirements of the Public Audit (Wales) Act 2004 (the 2004 Act) and guidance issued by the Auditor General for Wales.

Audit opinion: Qualified

Except for the matters reported below in my Basis for Qualification, on the basis of my audit, in my opinion no matters have come to my attention to give cause for concern that, in any material respect, the information reported in this Annual Return:

- has not been prepared in accordance with proper practices;
- that relevant legislative and regulatory requirements have not been met;
- is not consistent with the Council's governance arrangements; and
- that the Council does not have proper arrangements in place to secure economy, efficiency and effectiveness in its use of resources.

Basis of Qualification

Accounting Statement

In my opinion, the Accounting Statement does not properly present the Council's receipts and payments financial position:

- An issue raised in last year's audit has not been rectified in this year's audit. The Council incorrectly recognised VAT income in line 2 of the annual return rather than line 3 of the annual return in the 2022-23 financial year and did not amend for this error within this year's annual return.
- The Council has not provided a properly completed bank reconciliation as at 31 March 2024.

Annual Governance Statement

In my opinion, the Annual Governance Statement is not consistent with the Council's internal controls and governance arrangements for the year:

- Assertion 2: adequate internal control. The Council's internal auditor has highlighted areas of weaknesses which are inconsistent with the Council's Annual Governance Statement. The internal auditor answered 'No' to question 7 on the internal audit report. The Council must ensure it addresses the issue to receive a 'Yes' answer as part of future audits.

Other matters and recommendations

I draw the Council's attention to the following matters and recommendations which do not affect my audit opinion but should be addressed by the Council.

Approval and certification of accounts

The Council did not provide a minute reference indicating when their annual return was approved. We recommend that the Council include the minute reference on their annual return indicating when the annual return was approved.

Financial Regulations

The Council did not provide us with financial regulations nor were they present on their website. We recommend that the Council provide their financial regulations to ourselves as part of future audits when requested.

There are no further matters I wish to draw to the Council's attention.

The following information is provided to assist the reader to understand the accounting statement and/or the Annual Governance Statement

1. Expenditure under S137 Local Government Act 1972 and S2 Local Government Act 2000

Section 137(1) of the 1972 Act permits the Council to spend on activities for which it has no other specific powers if the Council considers that the expenditure is in the interests of, and will bring direct benefit to, the area or any part of it, or all or some of its inhabitants, providing that the benefit is commensurate with the expenditure. Section 137(3) also permits the Council to incur expenditure for certain charitable and other purposes. The maximum expenditure that can be incurred under both section 137(1) and (3) for the financial year 2023-24 was £9.93 per elector.

In 2023-24, the Council made payments totalling £3590.44 under section 137. These payments are included within 'Other payments' in the Accounting Statement.

2. Statement of income and expenditure/receipts and payments:

Line 2: Is the precept of £8000

Line 3: The £12,112 total includes the Shared Prosperity Funding (SPF) – Sustainable Communities grant funding administered through Carmarthenshire County Council for community project work (£11,760), VAT refund 23/24 (£345.43) plus bank interest (£5.81)

Line 6: The £27,461 total includes signage costs (£998) hence the increase in long-term assets recorded in Line 12; public lighting; admin and website development and management; S137; meeting venue costs plus £17,760 SPF grant funding paid out to project contractor, thus making expenditure/payments substantially higher in 2023/24 compared to previous years. As of 31 March 2024, SPF grant project is ongoing for 2024/25
