1. Expenditure under S137 Local Government Act 1972 and S2 Local Government Act 2000

Section 137(1) of the 1972 Act permits the Council to spend on activities for which it has no other specific powers if the Council considers that the expenditure is in the interests of, and will bring direct benefit to, the area or any part of it, or all or some of its inhabitants, providing that the benefit is commensurate with the expenditure. Section 137(3) also permits the Council to incur expenditure for certain charitable and other purposes. The maximum expenditure that can be incurred under both section 137(1) and (3) for the financial year 2022-23 was £8.82 per elector.

In 2022-23, the Council made payments totalling £1,910.00 under section 137. These payments are included within 'Other payments' in the Accounting Statement.

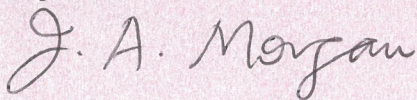

Auditor General's report and audit opinion

I certify that I have completed the audit of the Annual Return for the year ended 31 March 2023 of **Cilymaenllwyd Community Council**. My audit has been conducted on behalf of the Auditor General for Wales and in accordance with the requirements of the Public Audit (Wales) Act 2004 (the 2004 Act) and guidance issued by the Auditor General for Wales.

Audit opinion: Qualified

Except for the matters reported below in my Basis for Qualification, on the basis of my audit, in my opinion no matters have come to my attention to give cause for concern that, in any material respect, the information reported in this Annual Return:

- has not been prepared in accordance with proper practices;
- that relevant legislative and regulatory requirements have not been met;
- is not consistent with the Council's governance arrangements; and
- that the Council does not have proper arrangements in place to secure economy, efficiency and effectiveness in its use of resources.

Basis of Qualification

Accounting Statement

In my opinion, the Accounting Statement does not properly present the Council's receipts and payments and financial position:

- The Council has recorded £989 of VAT receipts within line 2.
- The Council has included £310.19 VAT receipts that was claimed and received in the 2023-24 financial year. Therefore the Council's receipts and balances are overstated.

Annual Governance Statement

In my opinion, the Annual Governance Statement is not consistent with the Council's internal controls and governance arrangements for the year:

- Assertion 2 – adequate internal control. Schedule of payments to be approved by the Council were not always complete.
- Assertion 3 – noncompliance with laws, regulations and codes of practice. The Council does not operate PAYE as it is required to do under the Income Tax (Earnings and Pensions) Act 2003. Failure to operate PAYE exposes the Council to the risk of fines and/or penalty charges being imposed by HM Revenue and Customs.
- Assertion 3 – noncompliance with laws, regulations and codes of practice. The Council has not provided evidence that a budget has been set in accordance with the Local Government Finance Act 1992 and that the precept has been set in line with the budget. The Act requires the Council to take into account its level of reserves and income when setting its budget requirement. We recommend that the Council sets a budget in accordance with the 1992 Act for future years.

- Assertion 8 – response to audit recommendations. The Council has failed to appropriately address matters raised by the previous external audit certificate.

Other matters and recommendations

I draw the Council's attention to the following matters and recommendations which do not affect my audit opinion but should be addressed by the Council.

Council Approval Checks

The Internal Auditor signed the Annual Return after the Chair. We recommend that going forward, arrangements are put in place to ensure the Internal Auditor signs the Annual Return before the Chair.

Section 137 Disclosure

The Council's section 137 disclosure is inaccurate and includes payments totalling £35 that did not rely on section 137 of the Local Government Act 1972. We recommend that the Council discloses its section 137 expenditure accurately.

Typographical and rounding errors

There is a £1 rounding error in Line 7 of both the 2021-22 comparative and the 2022-23 accounting statements.

We recommend that before it approves the accounts each year, the Council ensures the consistency and arithmetic accuracy of the accounts.

There are no further matters I wish to draw to the Council's attention.
